Councilor Gary Paul is the new commission liaison.

Chairman Marelli met with representatives of Avalonia Land Conservancy and from Ledyard High School to discuss working together for an integrated trail system for high school students to use the High School/Burton Trail/Pike Marshal properties. The 1967 Ledyard High School Alumni Association has created a fund to help develop a trail system and create other opportunities for high school students to use the property.
