**V. PUBLIC COMMENTS****1. Public Comments.**

Mr. Schroeder returned to the Conservation meeting with updates on a proposal for a zoning overlay map for about a quarter acre in Gales Ferry District to establish a Village District, which would be a tool the Town could use when looking at development proposals. Mr. Schroeder was not asking for a formal decision from the Commission but rather involvement in developing such a district.

Ms. Roberts-Pierson presented a letter from Mary Brown and herself, asking the Commission to support the proposal to re-designate Gales Ferry Village to a Village District to maintain the Village's colonial history and preserve the unique ecology of the area for wildlife, water flow and purification, and passive recreation. Ms. Roberts-Pierson also asked about maintenance at the White-Hall property and was hoping paths could be cleared so the public would have better access.

Mr. Schroeder also alerted the Commission to proposed parking changes in the zoning regulations that would weaken the Town's ability to preserve such elements as stone walls and natural topography. The Planning and Zoning Commission will be discussing the proposals at its May 14, 2026, meeting.

Chairman Marelli and Mr. Cohen put up a table at the Alliance for Mystic River Watershed's third anniversary gathering.

Mr. Cohen said Jon Vander Werff of Trout Unlimited asked if he could make a virtual presentation to the Commission at its next meeting. It will be arranged.

Ms. Graham invited the Commissioners to attend the state Office of Aquatic Invasive Species talk on May 16, 2026, from 9:30 a.m. to 12:30 p.m., at the Gales Ferry Senior Center.

Chairman Marelli said one of the Town's future projects would be to look at uses of Pfizer Field. The land is owned by Pfizer and only the baseball fields are open for Town use. There are other trails through the property.

Chairman Marelli reported that he is counting herring.

The tree at Burton Park has been removed.

Nomination for Aquarion Environmental Award for Maggie Favretti has been submitted.

A proposed subdivision at 58 Silas Deane Road will include a 10-foot strip of land for connection to Avalonia open space trails.
