Re: Retirement Plan for Full-Time Employees of the Town of Ledyard – Calculation for Steven Masalin

Dear Marisa:

As requested, we have prepared the **UPDATED** attached Benefit Calculation Worksheet for Steven Masalin for a February 1, 2024, retirement date. The update from the initial calculation is a termination date change to January 27, 2024. Based on the projected compensation provided for the period ending January 27, we've calculated that Mr. Masalin is eligible to receive a monthly retirement benefit of \$4,718.05 as of February 1, 2024, payable in the normal form of a Modified Cash Refund Annuity, and \$4,000.91 if he elected a 50% Joint and Survivor annuity, based on his service and earnings through this retirement date. In addition, Mr. Masalin's employee contributions with and without interest will be \$224,084.53 and \$123,053.05, respectively, as of that same date. The non-taxable portion of the monthly benefit will be \$473.28 for 260 months if he elects the Modified Cash Refund or a 10-year Certain & Life Annuity, or \$396.95 for 310 months for a joint & survivor annuity. Please note that Mr. Masalin's benefit and accumulated employee contributions as of February 1, 2024, are based on expected pay and contributions, thus these benefit amounts may need to be recalculated if actual pay and contributions are different once finalized.

The calculation is based upon a 1.5% multiplier but limited to 50% of the participant's three-year average salary. These are the current plan provisions in effect for Administrative Non-Union Professionals. Our calculation of the referenced pension benefit is based on the service, compensation and other relevant information provided to us by the Town of Ledyard. USI Consulting Group has not independently confirmed the accuracy or completeness of such information.
