Dear Mrs. Riley:

At its regular meeting held on April 23, 2025 the Town Council voted to change the location of the Annual Town Meeting regarding the proposed Fiscal Year 2025/2026 Budget scheduled for May 19, 2025 at 7:00 p.m. to be held at the *Council Chambers, Town Hall Annex Building;* 741 Colonel Ledyard Highway, Ledyard, Connecticut, and to adjourn to a Referendum to be held on May 20, 2025 between the hours of 6:00 a.m. 8:00 p.m.

In addition, the Town Council adopted a Fiscal Year 2025/2026 Budget in the amount of \$71,062,240; comprised of General Government of \$30,394,998 and Board of Education of \$40,667,242 to present to the voters at the May 19, 2025 Annual Town Meeting.

At its conclusion, the question presented below will be submitted to a vote upon the voting machines on May 20, 2025 as follows:

"Shall the Town of Ledyard adopt a Fiscal Year 2025/2026 Budget as proposed by the Town Council in the amount of \$\sqrt{\$71,062,240}\?"

(comprised of General Government of \$30,394,998; and Board of Education of \$40,667,242)

Should the Referendum fail, the subsequent Referenda will be held between the hours of 12:00 p.m. and 8:00 p.m.; in accordance with Chapter VII, Section 6 of the Town Charter.

The Town Council also acknowledged (4/9/2025 meeting) that in accordance with Chapter VII; Section 7 of the Town Charter that the following *Advisory Questions* will be placed on May 20, 2025 Ballot:

In addition, at their April 16, 2025 Special Meeting the Town Council voted to place the following questions on the voting machines on May 20, 2025 under the following heading:

"SHALL THE TOWN OF LEDYARD APPROPRIATE AN ADDITIONAL \$1,250,000 (INCREASING THE APPROPRIATION AND BORROWING AUTHORIZATION TO AN AGGREGATE \$9,800,000) FOR VARIOUS SCHOOL IMPROVEMENT PROJECTS, AND AUTHORIZING THE ISSUANCE OF BONDS AND NOTES IN THE SAME AMOUNT TO FINANCE THE APPROPRIATION?"
