**Subject:** Re: Bruce Edwards. Leader of the CAVE people

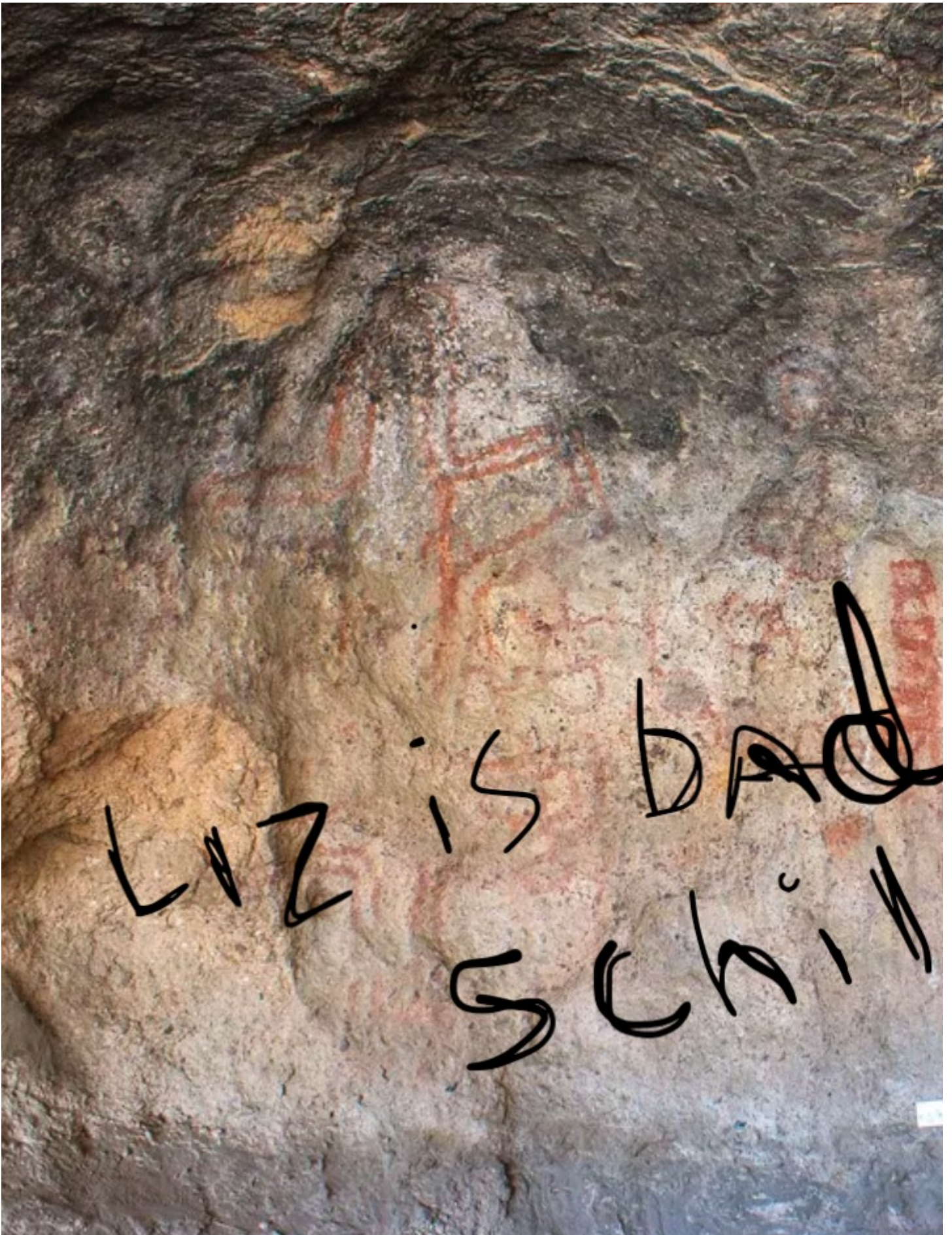

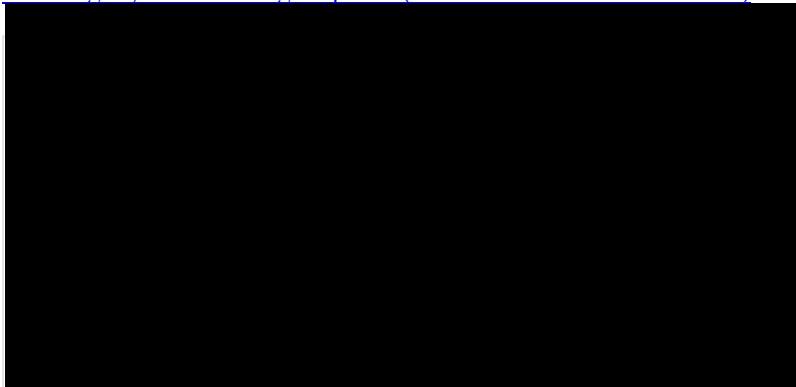
