1. Town Council Liaison - Councilor Tim Ryan.

rough estimate. He added that all are invited to attend the next Finance Committee meeting to discuss this further. Chairman Lamb said he would attend the next Finance meeting.

VIII. CHAIRMAN REPORT

1. General Report.

Chairman Lamb attended the last Ledyard Beautification Committee meeting. The LBC had intended to attend this meeting, but they were not present, there may have been a miscommunication. The LBC may possibly hold a Veterans Day event/presentation. They may ask for assistance from the Town Council. The LBC would like to display Veterans pictures on "election day" type signs to promote Ledyard Veterans.

There are lead concerns at the Nathan Lester House.

Any projects over and above the present ARPA projects will need to be presented to the Finance Committee. Chairman Lamb requested that the plans are given to him. He will need the drafts by the end of August.

Chairman Lamb will attend the next Finance Committee, Administration Committee and the Land Use/Planning/Public Works Committee meetings.

The street sign direction/marker for the Nathan Lester House needs to be placed in a better location.

X. COMMITTEE REPORTS

1. Sawmill Committee - Mr. Barnes.

Chairman Lamb said that Mr. Kelley and Mr. Barnes can still use the Holdridge account, but they must get invoices and follow timely submission.

Reported issues getting the blades sharpened, looking into other options.

Dam permit updates: An engineering company would charge \$20,000.00 for permit assistance only. Mr. Godino has volunteered to help with the permit, he has started the draft. CT form GP-015 PE needs to be completed. The Permanent Municipal Building Committee has access to the State forms and may be able to provide assistance. Mr. Barnes has an engineering license and can help with the application process.

There are several smaller ARPA projects on the list. Will need to use capital once the ARPA funds are exhausted. Councilor Ryan added to keep in mind that the projects need to be obligated in this calendar year but does not need to be spent in the calendar year.

Two cost estimates from John Kelley-

Black Smith Shop and exterior repairs approximately \$10,000.00. Beth Ackley has the structural assessments; these results might affect what work will be completed.

2. Nathan Lester House - Mr. Kelley.

Attendance at the NLH on open weekends is down significantly from last year. Lower attendance is attributed to the weather, as well as the Fog of War film settings being taken down, which was a big draw last season. The barns have not been restaged with the permanent collection yet as they are being used for materials storage for restoration.

The new barn doors on the front of the main barn have been completed to satisfaction. They are modeled on the existing door immediately to the right and give the intended impression they are original to the structure.

Working with Ledge Light to evaluate the lead situation. Ordered to stop all work. Sharon Primmit, NLH Caretaker was loaned a HEPA vacuum to start the cleaning. The contractor lent a second HEPA vacuum for the historical area. There will be discussions for the facilitation of future actions through Mr. Kelley.

Ms. Chittim was not present. There will be a kickoff meeting with Gosha regarding the pollinator garden on August 2, 2024. In the process of setting up "dig safe" with the State. The project will start in the fall.
