
At its Special Meeting held on April 16, 2025 the Town Council took the following actions:

- Waived the reading in its entirety the “*Resolution Amending the Resolution Entitled “Resolution Appropriating \$8,550,000 for Various School Improvement Projects; And Authorizing the Issue of Bonds And Notes in the Same Amount to Finance Said Appropriation” To Increase the Appropriation And Borrowing Authorization To \$9,800,000*”.
- Approved the “*Resolution Amending the Resolution Entitled “Resolution Appropriating \$8,550,000 for Various School Improvement Projects; And Authorizing the Issue of Bonds And Notes in the Same Amount to Finance Said Appropriation” To Increase the Appropriation And Borrowing Authorization To \$9,800,000*”.

“SHALL THE TOWN OF LEDYARD APPROPRIATE AN ADDITIONAL \$1,250,000 (INCREASING THE APPROPRIATION AND BORROWING AUTHORIZATION TO AN AGGREGATE \$9,800,000) FOR VARIOUS SCHOOL IMPROVEMENT PROJECTS, AND AUTHORIZING THE ISSUANCE OF BONDS AND NOTES IN THE SAME AMOUNT TO FINANCE THE APPROPRIATION?”
