Absentee ballots will be available from the Town Clerk's Office.

Pursuant to C.G. S. 9-369c, eligible persons requesting an absentee ballot must apply in person at the Town Clerk's Office.

Central counting of absentee ballots will be conducted at Town Hall Lower Level, Registrar's Office.

Should the referendum fail, the adjourned Town Meeting will be reconvened on:

Tuesday, June 9, 2026 from 12:00 p.m. to 8:00 p.m. on the voting machines in accordance with Chapter VII, Section 6, of the Town Charter.

In the event that both referenda fail to pass a budget, the Town Council is required to adopt a Fiscal Year 2026/2027 Budget by June 22, 2026.
