2. Update & Discussion on Roof Projects

Mr. Donaldson stated that the tentative date for the delivery of the metal panels for Gales Ferry School is the first week of August. Juliet Long School is halfway complete with the demolition and first base coat of roofing. The right side of the building should be complete this week. Mr. Donaldson shared it was brought to his attention a potential issue with the auditorium roof; Silver Petrucelli & Associates had the auditorium roof listed as a flat roof with four drains,

however it is a sloped roof with two drains. Mr. Donaldson stated that additional blocking on the front walls will be required. Mr. Donaldson added that he will have more information regarding the issue at the next meeting.

Mr. Hosey inquired where Silver Petrucelli & Associates had gotten the information that the roof was flat with four drains. Mr. Donaldson replied that the original prints had the roof as flat and something must have changed. Chairman Schneider requested a report from the project manager on the impact this issue would have on cost and timeline. Mr. Rongey replied that he will work to have a change order for the next meeting. There should not be any impact on the timeline for the project. Mr. Donaldson added that he will have additional information from Silver regarding the auditorium roof before the next meeting.

Mr. Donaldson shared that the projects are moving along well. there have been some small leaks from the roofing projects, with nothing significant. Mr. Rongey added that he hopes to have a hard date for the delivery of the metal panels before the next meeting.
