Dear Mayor Allyn:

At its Regular Meeting held on March 26, 2025 the Town Council took the following actions:

- Adopted the proposed "Resolution of the Town of Ledyard to Adopt an Optional Motor Vehicle Depreciation Schedule" as presented in the draft dated March 10, 2025.
- Adopted a proposed "Resolution to Call on the Connecticut State Legislature to Support Legislation Which Aims to Eliminate The Public Benefits Charges On Electric Bills for Connecticut Residents And to Fix Systemic Issues Which Enables Such Fees And Charges".
- Authorized the purchase of fire apparatus (brush truck) in the amount of \$320,479.60 for Gales Ferry Fire Co from account # 0210-20-2040-54325 (AES Fire Apparatus CNR).
- Authorized a Bid Waiver for CWPM, LLC for Bid No. 2025-04 (Trash and Recycling Collection Services) due to lack of three bids, in accordance with Ordinance #200-001 (rev 1) "An Ordinance for Purchasing."
- Appropriated and transferred the Board of Education Fiscal Year 2024/2025 audited surplus of \$118,629 from unrestricted fund balance to Account #22570101-58250 (BOE Reserve Fund) in accordance with "Resolution Creating a Funding Mechanism for Making Annual Appropriations to a Capital Reserve Fund for the Board of Education" adopted on September 28, 1988.
- Reappointed the following members to the Cemetery Committee for a three (3) year term ending April 26, 2028:
  - ✓ Mr. William Vidal, III, (D) 183 Spicer Hill Road, Ledyard (Regular Member)
  - ✓ Mr. Vincent Godino (D) 1906 Center Groton Road, Ledyard (Alternate Member)
- Reappointed Mr. Charles Duzy (R) 4 Harvard Terrace, Gales Ferry, to the Housing Authority for a five (5) year term ending March 31, 2030.

- Approved a tax refund to Corelogic Centralized Refunds, P.O. Box 9202, Coppell, TX 75019-9760 in the amount of \$2,454.84.
- Appointed Mr. James Harwood (D) 10 Eska Drive, Ledyard as a Regular Member of the Planning & Zoning Commission to complete a three (3) year term ending December 31, 2026 filling a vacancy left by Mr. Whitescarver.
- Appointed Ms. Rebecca Watford (R) 429 Colonel Ledyard Highway, Ledyard, as an Alternate Member to the Historic District Commission to complete a five (5) year term ending December 6, 2028 filling a vacancy left by Mrs. Parkinson.
