
At its Regular Meeting held on April 9, 2025 the Town Council took the following actions:

- Adopted a proposed Fiscal Year 2025/2026 Budget in the amount of **\$71,062,240** comprised of:
 - General Government: **\$30,394,998**
 - Board of Education: **\$ 40,667,242**
- Set a Public Hearing date (Hybrid Format - Video Conference and In-Person) to be held on April 21, 2025 at 7:00 p.m. to be held in Ledyard Middle School Auditorium, 1860 Route 12, Gales Ferry, Connecticut, to receive comments and recommendations regarding a proposed Fiscal Year 2025/2026 Budget.
- Set the Annual Town Meeting date (Hybrid Format Video Conference and In-Person) regarding the proposed Fiscal Year 2025/2026 Budget to be on May 19, 2025 at 7:00 p.m. to be held at the Ledyard Middle School Auditorium, 1860 Route 12, Gales Ferry, Connecticut; and to adjourn to a Referendum to be held on May 20, 2025 between the hours of 6:00 a.m. 8:00 p.m.
- Acknowledged the following “*Advisory Questions*” will be placed on the May 20, 2025 Referendum, in accordance with Chapter VII, Section 7 of the Town Charter:
 - 1.) Do you believe the **Board of Education budget** is:
 - Too High
 - Or
 - Too Low
 - 2.) Do you believe the **General Government budget** is:
 - Too High
 - Or
 - Too Low

- Adopted a proposed Fiscal Year 2025/2026 Water Operations Budget in the amount \$1,765,531.80.
- Approved a proposed “*Amendment 2025-1 to the Town of Ledyard 401(a) Plan*” pertaining to Employees eligible for Matching Contributions; as presented by the Retirement Board in the draft dated March 18, 2025.
- Allocated up-to \$12,500 from the National Opioid Settlement Funding (Account #20810201-58206-24206) to support the Fiscal Year 2025/2026 administration of the DARE Program in Ledyard Public Schools.
- Authorize the overspending of Account #10120501-54300 Ledyard Fire Repairs and Maintenance by an amount not to exceed \$6,000.
