Mr. Tony Capon & Ms. Juliet Hodge,

In regard to Kevin Blacker's emails he does not have all of the information. Some of our citizens had planned to get together to create a committee to organize concerns and hopefully minimize impacts on our community if/when Cashman and other companies begin operating. The district decided we should form a committee outside of the district as this implementation affects other towns and is much more far reaching. This meeting was also not directed at just Cashman but the entire industrial marine hub coming to fruition. We had talked about the meeting for some time. We asked many questions about the process, zoning regs and time tables. We have many emails insinuating that if this hub is coming we were hoping to minimize impacts and keep a watchful eye on the environment, etc. When we reached out to Juliet (last minute) she realized it might be easiest to come answer some questions about the process and how it works. The meeting was educational-It was helpful but as all of our emails will show we still were operating on the fact they will probably be coming in, and Ms. Hodge persistently did not take any side. P&Z stood by the fact they had to go by the books not by what people want. There was discussion about over populating the next meeting as they would have nothing on the table (permit) to even discuss and just inhibit the process. We have since organized the steering committee. I do not want to incite Mr. Blacker further but want to ensure everyone that our emails are pretty clear there is no form of collusion with the town and also we have done nothing but try to keep everything to the facts as much as possible even on the group page, where we have often deleted rhetoric such as these threads.
