VI. PLANNER REPORT

New Businesses: One potential new commercial services business which will come up for public hearing in December. Dollar General has foundation approval. Public meeting for Cashman Project (former Dow Chemical Site) related to their DEEP Permit possibly on November 17th. Other: Annual report time getting caught up with grants. October issue of the Connecticut Economic Digest has their annual Town Economic Index for 2021. Land Use Administrative Asst. hired, started on Monday. Currently working with ZEO on several enforcement issues and active court cases

F. ARC Recycling Donation Station Placement (Carol)

Transfer station declined. Asking Senior Center/Parks and Rec before asking businesses. Waterford has approved one. Hoping for one in Ledyard Center and one in Gales Ferry.
