I. CALL TO ORDER - Chairman Vincent called the meeting to order at 6:00 p.m. in the Council Chambers of the Town Hall Annex Building. Chairman Vincent welcomed all to the Hybrid Meeting.

III. ADDITIONS OR CHANGES TO THE ORDER OF THE AGENDA

#### IV. PRESENTATIONS / INFORMATIONAL ITEMS

A. Justin LaFountain of Goman & York: Update of GF Corridor Study

Justin LaFountain of Goman & York reviewed his presentation with the Commission concerning information gathered at the EDC Special Meeting of April 15<sup>th</sup> workshop. They reviewed slide 3 that displayed data on continuum of change desired on Route 12. They reviewed slide 4 which displayed data showing residents desiring more commercial development along the corridor as well as more single family home development.

Commissioner Cherry commented that the Gales Ferry Development District does not allow for any more new single family homes and that the data. He stated the town would need to enact zoning changes.

They reviewed data collected on the importance of affordable housing in Ledyard which averaged in the middle. They reviewed data on whether the residents wanted to see more restaurants or retail which showed more desire for restaurants. They reviewed data on whether residents do more of their shopping inside or outside Ledyard which was heavily weighted on outside Ledyard. They reviewed data on resident's preference for economic development or for preserving existing conditions which was heavily weighted to preserving existing conditions. They reviewed data on sorrys and prouds of Route 12. They reviewed data on beautification of Route 12. They reviewed data collected on desired economic investment.

Justin LaFountain and Commissioner Tashea discussed the potential impact of the redevelopment of the Old State Hospital property. Naomi Rodriguiz commented that the business on Crystal Lake Road may be installing new businesses.

The Commissioner briefly discussed the demographics of the residents that participated in the study and how it could have impacted the data. Justin LaFountain commented that in order to address the skewed data Goman & York has created a survey that replicates that questions from workshop into an accessible survey. Justin LaFountain and the Commission discussed ways to improve the survey and collect more accurate data as well as preventative measures for members to submit more than one survey response.

Director Burdick and Justin LaFountain discussed bike path sizes related to the survey.
