It does not identify the quarrying operation that is intended to go on for 8 or more years, with blasting, rock crushing, and likely runoff of toxic quarry dust into the river. The rock regrading will produce cliffs and level spaces between them that no future imaginary, identified or committed industry would construct a building.

Dear miss Burdick,

Section 11.6.10 of town regulations, titled **Notification of DEEP:** states that If any portion of the property which is the subject of an application within an area designated as "State and

Federal Listed Species & Significant Natural Communities"on the most current Natural Diversity Data Base Areas map for Ledyard prepared By DEEP, the applicant must notify DEEP of the application. **This is within such an area.**

A report from DEEP shall be required for any application for Site Plan approval or a Zoning Permit for any such property, and any such application submitted without a DEEP report shall be considered incomplete.

According to Ms Camille [Fontana@ct.gov](mailto:Fontana@ct.gov), as of Oct. 17 Cashman has **NOT** submitted an application for their proposal for quarry work or excavation work (same thing). Cashman did submit an application and received permission in April, 2024 for their pier work at the marine terminal.
