Anna,

Thanks for authoring the Sustainable CT Ad Hoc Committee's referral regarding Action 1.2.2 "Participate in Equity Training" and Action 1.3.1 "Develop and Adopt a Statement on Equity." (PS: My name is Gary St. Vil, NOT Gay St. Vil 😊)

Given the nature of these requests, the Town Council would benefit from a briefing from the Ad Hoc Committee and I would like to put this on a future Town Council agenda for discussion and presentation. Right now, I have several questions, including:

- Whether these actions are required for Bronze Certification or only for Gold Certification;
- Whether alternative actions exist that could satisfy equivalent point requirements;
- Whether qualifying equity training has already occurred within the last three years;
- What specific training content, format, and providers are being contemplated;
- What municipal obligations or policy implications may result from adoption of an equity statement;
- Whether draft examples from comparable municipalities are available for review;
- What anticipated staffing or administrative impacts may result from these actions; and
- What timelines or deadlines exist for Council consideration.

A public briefing and discussion will allow the Council to better understand the certification requirements, expected outcomes, and any associated impacts prior to determining next steps.

Please work with Roxanne to add this topic to a future Town Council meeting agenda.
