Harned has stated on record he is speaking for CALU, a corporation. Does this open him to requirements/exposure to lobbying? Think of the Treaster attempt to hamstring GFI by changing zoning regs and those who supported that, but I think even spending \$ attempting to influence administrative action can trigger lobbying laws.

Does Louiero have recordings of 2022 informal zoom. Did any member of zoning prejudice themselves in those hearings? Would review comments of speakers at those.
