**VII. OLD BUSINESS**

1. Holiday Programs 2022

Ms. Chapman shared an update on the holiday programs. At the Thanksgiving event Ledyard Social was able to provide food baskets and \$20 grocery store gift cards for 67 households. For the Christmas event Ledyard Social Services provided food baskets and \$20 gift cards for 82 household. 101 children received gifts from community members. Ms. Chapman stated that she appreciated the support of Gales Fire Company for allowing the use of their hall and grateful for the staff and volunteer support provided at the event from both fire companies. Ledyard Public Works also assisted with the events along with Food Pantry volunteers. Ms. Chapman stated that remaining gifts were donated to St. Vincent DePaul Place, an organization serving the larger Norwich area community. Ms. Chapman stated that 41 community members and organizations participated in the holiday programs by providing food baskets or adopting a family to provide gifts.

Ledyard Rotary Foundation along with the Liberty Bank Foundation and raised \$4,216.75 towards food baskets. Ledyard Social Services worked with Village Market and utilized these funds to purchase 50 food baskets and 85 \$20 Stop & Shop grocery gifts cards with funds

remaining for next year's program. Mayor Allyn III added that the thought behind the gift cards was to get away from storing and handling turkeys. The use of gift cards also gives guests the flexibility to purchase a protein of choice for the holiday meal.

Mayor Allyn made the Board aware that LICEAF (Ledyard Inter Church Emergency Assistance Fund) will be sending out their spring fundraising letter in April. Mayor Allyn shared that this organization does a lot of good work in the town by offering emergency grants for rent and mortgage assistance, car repairs, utility assistance ect.. Mayor Allyn noted that this past year LICEAF took in approximately \$15,000 in donations and has paid out \$34,000 in grants to Ledyard Social Services Clients.

2. Food Pantry Updates

- Rotary Foundation Partnership
- Connecticut Foodshare Fee Structure Update

Ms. Chapman shared that the Linda C. Davis Food Pantry has partnered with the Rotary Foundation as a 501c3 sponsor of the food pantry. This sponsorship will allow the pantry to access all donated and purchased food products through CT Foodshare. The only options available to the pantry up until this point have been TEFAP (The Emergency Food Assistance Program) USDA commodities. Ms. Chapman stated that 5-7 items were previously available each week and we are now seeing 3-4 pages of products avialable. Ms. Chapman stated that the sponsorship from the Rotary Foundation will allow us to access donated product from many grocery chains such as Whole Foods, Costco and BJ's.

Ms. Chapman also gave an update on the new fee structure CT Foodshare will be implementing. During the time that the Linda C. Davis Food Pantry has been partnered with CT Foodshare all fees have been waived. During the qaurtlerly meeting Ms. Chapman attending, CT Foodshare sahred that it is unsustainable without the additional funding CT Foodsshare was able to access during the pandemic to continue a \$0 fee structure. The following structure will take place beginning on July 1, 2023.

- No Membership Fee
- No Shared Maintenance fees on donated food (government food will continue to have no fee)

- No Delivery fees
- Grocery Purchasing Program (GPP) All purchased food at 100% cost (w/no markup)

Ms. Chapman stated that CT Foodshare has begun charging 50% for several purchased items at this time. Ms. Chapman also stated that with the buying power CT Foodshare has the cost of items will still be much less than purchasing food at retail from other locations such as Aldi or Village Market.

Ms. Chapman also shared that CT Foodshare has an Outreach team able to assist with SNAP applications by calling 860-856-HELP.

Ms. Chapman shared that an additional \$20 million in funding has been approved by the Legislature for CEAP ( CT Energy Assistance Program). TVCCA (Thames Valley Council for Community Action) administers the program for Southeastern CT. Ms. Chapman stated that in real dollars this will equate to an additional \$430 in funding for those households that qualify. A household receiving the largest benefit available would receive \$2,320.

Ms. Shipley suggested that people go online and change their energy supplier. Ms. Chapman attended a webinar provided by Eversource and is able to provide residents with additional direction for those having trouble paying their bill. Mr. Grimm suggested that those who are able should explore the option of solar energy. Ms. Chapman stated that she continue to take energy applications.
