At its Regular Meeting held on February 22, 2023 the Town Council took the following actions:

- Set a Hybrid (In-Person & Video Conference) Public Hearing date on April 12, 2023 at 6:30 p.m. to be held in the Council Chambers, 741 Colonel Ledyard Highway, to receive comments and recommendations regarding a proposed amendments to Ordinance #100-016 (rev 1) "An Ordinance Combining Parks And Recreation Commission and Senior Citizens Commission for the Town of Ledyard" as contained in draft dated February 8, 2023.
- Appropriated and transfer the Board of Education Fiscal Year 2021/2022 audited surplus of \$448,253 from unrestricted fund balance as follows:
  - ✓ \$381,015 to Account #21070101-58250 (BOE Reserve Fund) in accordance with "Resolution Creating a Funding Mechanism for Making Annual Appropriations to a Capital Reserve Fund for the Board of Education" adopted on September 28, 1988; and
  - ✓ \$67,238 to Account #21070101-58262 (Track & Field Rental Reserve) (15% when surplus exceeds \$250,000) in accordance with "Resolution Regarding the Establishment of An Account for the Revenues Received from Leasing the Ledyard High School Multi-Use Facility" adopted on April 22, 2020.
- Adopted proposed revisions to the "Resolution Establishing Administrator/Department Head Benefits" as contained in the draft dated February 15, 2023.

Window sills and drywall would also need to be replaced after the shutters are installed. Estimate is about \$25,940. This includes electrical work as well.

2. Discussion and possible motion to allow Ledyard Little League to install a new scoreboard at the Senior Field at Pfizer

Ledyard Little League scoreboard at the Senior Field at Pfizer - Jim Russell appeared on behalf of Little League. The request is for Parks & Recreation would support by installation a pole. Little League is willing to pay for the electricity if they are the only ones using it. (There is currently no power and no scoreboard at this location.) The scoreboard would allow Little League to host tournaments in town. The cost for the support being requested is about \$1800 - too low for the capital expense. Parks & Recreation hasn't yet identified if we have available funds to be able to consider supporting. Further research is needed before the Commission could consider approving any financial support.




## What is an Eagle Scout Project

- ► Skatepark in Ledyard
- ► Includes:
  - ▶ 1 stair set
  - ▶ 2 grind rails
  - ▶ 1 halfpipe
  - ▶ 3 quarter pipes
  - ► 2-3 roll-in ramps
  - ► Multiple side ledges
  - ▶ 2 pyramids

Where will the skatepark be?


- Highland Lake Park Ledyard, CT

## What I still need to do for my proposal


- ► Accurate measurements of area

- ▶ Identify tasks that the scouts can do


## What I will need to do in order to start


- ▶ Approval from Troop 16 Scout Committee.
- ▶ Approval Ledyard from Parks and Rec.
- Wetlands commission approval
- ▶ Planning and Zoning approval and an 8-24 review (a State required review of any improvements occurring on municipally owned property)
- ▶ Approval from the Town Council for constructing an improvement on Town owned property
- A financial review by the Town's insurer to determine what the impact would be to the Town's insurance coverage
- ▶ A building permit from the Land Use Department in Town Hall
- Start fundraising, applying for grants, accepting donations

## What I will need to do in the future

- Research the best concrete pouring company
- Find volunteers
- ► Research landscaping companies
- Find artists to do artwork
