AN ACT AMENDING THE CHARTER OF THE CONNECTICUT  
FIRE INSURANCE COMPANY.

SECTION 1. The annual meeting of the stockholders of The Connecticut Fire Insurance Company shall be held after the present year on such day in the month of February in each year as shall be appointed by the directors.

SEC. 2. The stockholders of The Connecticut Fire Insurance Company at each annual meeting held after the present year shall elect a board of directors consisting of not fewer than seven nor more than fifteen stockholders, such board to be elected and to hold office in the manner provided in the charter of said company and to have all the powers given to the board of directors therein.

SEC. 3. This amendment shall not become operative unless, within one year after its passage, it shall be accepted at a special meeting of such corporation warned and held for that purpose or at the next annual meeting of such corporation, which shall be held on such day in the month of February, 1948, as shall be appointed by the directors, and unless an attested copy of said acceptance shall be filed in the office of the secretary of the state within thirty days from the date of such meeting accepting this amendment.

SEC. 4. Any provision of the charter of said company inconsistent herewith is repealed.

AN ACT INCORPORATING THE GALES FERRY FIRE DIS-  
TRICT.

SECTION 1. The territory of the town of Ledyard, bounded as follows: Beginning at a point on the east bank of the Thames river and the southerly boundary of Clark's cove, thence in an easterly direction to a stone wall between Joseph DeRusha and estate of Latham E. Smith properties, continuing easterly across route 12 for about 500 feet, more or less, to a stone wall running north and south on

the property of Irving Hurlbutt, thence southerly along stone wall to Christy Hill road, thence westerly along said road to easterly boundary of Trout Brook road, thence southerly along said road to stone wall dividing the properties of Carl W. Brown and Alice Satterlee, following said wall to the right of way of the New York, New Haven and Hartford Railroad Company, thence southerly along said railroad right of way to a point in the line of the southern boundary of property of Mrs. George Frost, thence westerly along said boundary to the east bank of Thames river, thence northerly along the bank of said river to the beginning; is declared to constitute the Gales Ferry Fire District, and the inhabitants residing therein are made and constituted a body politic and corporate by the name of the Gales Ferry Fire District.

SEC. 2. Said Gales Ferry Fire District is authorized and empowered to organize and maintain fire, hook and ladder, and hose companies, and to purchase hose and other appliances for the extinguishment of fire, and to provide suitable buildings and places for keeping the same; to provide a sufficient supply of water for fire and other purposes for use within said district; and to establish and enact all by-laws that may be deemed necessary and expedient to carry out the provisions of this act. Theodore P. Robison, Freeman E. Kenerson, Harold F. Bartlett, R. Irving Hurlbutt, Ruth B. Allyn and Stewart A. Leard, or any two of them, are authorized and directed to call the first meeting of the legal voters of said district at such time and place within said district as they may determine.

[Senate Bill No. 202.]

AN ACT AMENDING THE CHARTER OF THE CITY OF WATERBURY BY PROVIDING FOR THE APPOINTMENT OF MINORITY MEMBERS ON THE BOARDS OF SAID CITY.

SECTION 1. Section 30 of the charter of the city of Waterbury, being section 33 of number 499 of the special acts of 1931, is amended by adding thereto the following: "The minority members of said board shall elect a minority leader who shall serve as such minority leader during the term for which he shall have been elected as a member of said board, and in the event that said office becomes vacant by reason of the death, resignation or removal of an incumbent thereof, the minority members of said board shall elect a successor to hold office for the unexpired portion of such term."

SEC. 2. Notwithstanding any other provision of the charter of the city of Waterbury, the mayor of said city shall make no appointment of a minority member of any board for which provision is made in said charter to be filled by appointment by the mayor
