Good afternoon Liz,

A neighboring property owner told me he “heard” at town hall that Habitat won’t be allowed to tie into sewer on Col. Ledyard, and everyone needs to wait for the Fairway extension. When we last met in your office we were told we wouldn’t have to wait, and have since spent a significant amount of time and money on engineering and testing, with grant applications that say we’ll start next spring or summer.

I’m asking for confirmation that our project is in the town’s plans. We can’t apply for funding if the extension is a year or more away, and everything we’re doing (spending) now is preparing for the upcoming rounds of CIF and CDBG in December and April, respectively.

11/11/24 Sarah, I was on vacation all last week, but I did forward your email to the DPW Director Steve Masalin and the WPCA Chair Ed Lynch while I was away and I received the following responses:

Ed Lynch: We still have not received any definitive plans from Habitat but be that as it may the only requirement that Weston and Sampson has stipulated is that grinder pumps will be required for waste tie-ins. It is true that various options have been suggested for tie-in placement, but it has always been assumed that Colby drive would have to be developed by or for Habitat to have access to Colonel Ledyard Highway. And yes, there is the concern of not digging up the trail to gain access to the sewer line - however a tee tie-in can be installed and if that is an issue I was told by Weston and Sampson that we could tie-in to the Ledyard center node at the library.

My suggestion is that Habitat contact Weston and Sampson directly so that all these options can be discussed and a plan of action developed in a timely manner.

Steve Masalin: I don't ever remember there being a firm commitment to what they had proposed. There was also a central pump station being proposed to serve all their units, that Weston and Sampson said it's not suitable for the low pressure main. If they aren't going to integrate their project into the system as designed to function, they would need to bear the entire burden of installing a line up the hill and tying into the line at Colonel Ledyard Highway. That intersection is now completely paved and finished. And they would have to accommodate the requirement to have pumps from individual units.
