Dear Marisa:

As requested, we have prepared the attached Benefit Calculation Worksheet for Michele Maynard for November 1, 2023, retirement date. Based on the final monthly benefit information provided, Ms. Maynard is eligible to receive a monthly retirement benefit of \$373.50 as of November 1, 2023, payable in the normal form of a Modified Cash Refund Annuity. In addition, Ms. Maynard's employee contributions with and without interest will be \$19,025.09 and \$10,352.98, respectively, as of that same date. The non-taxable portion of the monthly benefit will be \$39.82 for 260 months if she elects the Modified Cash Refund or a 10-Year Certain & Life annuity.

Our calculation of the referenced pension benefit is based on information provided to us by the Town of Ledyard. USI Consulting Group has not independently confirmed the accuracy or completeness of such information.
