Eversource has reviewed your request (Customer Request # 17885214) for service at 1854 Route 12, Ledyard, CT and tentatively agrees to provide electric service on or before Friday, 12/13/2024. To enable Eversource to schedule and complete your service by this date it will be necessary for you to satisfy all applicable requirements listed below on or before their specified date.

**Electrical inspection** to be completed by applicable authority on or before: 11/22/24

**Contribution** must be received by the Company on or before: 11/22/24

**Easement** must be recorded with Municipality on or before: Not Applicable

**Trench and conduit work** must be completed by Customer on or before: 11/22/24

**Tree trimming work** must be completed by Customer on or before: 11/22/24

**Telephone Pole(s)** must be set by Telephone Company on or before: Not Applicable

Eversource will electronically notify the party identified as the "Primary Contact" 7 days before the required by date if the requirement is not completed.

Customer acknowledges and agrees that any and all dates provided by the Eversource in the complex check List in connection with the provision of new electric service are estimates and subject to change by Eversource. Accordingly, Customer waives and releases Eversource and its affiliates and their employees, agents and representatives from and against any and all claims, damages, losses and expenses (including reasonable attorney's fees) arising out of or relating to any changing, rearranging or rescheduling of dates provided herein, including but not limited to, changing of dates due to failure of the Customer to perform Customer's responsibilities (e.g. payment of Customer's contribution, tree trimming by Customer) in connection with the provision of new electric service by Eversource.

The total amount due is \$11,223.69 (Please make check payable to Eversource) This amount includes \$210.59 for loading and travel costs. Traffic control costs are included, if applicable.

The Internal Revenue Code of 1986 mandates that "contributions in aid of construction" (CIAC) are considered taxable income to the receiving utility. Eversource is required to pay income tax on these contributions. The total tax liability for this project is \$1,548.09, which is 16% of your CIAC contribution of \$9,675.59.

The amount is valid for 90 days and assumes average working conditions. Additional charges may apply if we encounter unusual conditions (rock, water, frost, etc.). All tree trimming, trenching, conduit and blasting on private property are the responsibility of the property owner.



