Good afternoon,

Thank you for the helpful responses and information provided below.

Regarding the seasonal high groundwater, if estimated seasonal high groundwater (ESHGW) is not determined from redoximorphic features, then the observed groundwater will be determined based on seepage from the sidewalls of the excavation. If neither redoximorphic features or seeping is observed, then the groundwater monitoring well levels will be used to determine groundwater level. In previous test pits, ESHGW was determined in 8 of the 16 test pits.

Regarding referencing data from a nearby USGS monitoring wells, is there a maximum distance from the site that a well may be located in order to use reference data (assuming similar geologic setting)?

Hello Antoanela,

We are finalizing the additional geotechnical investigation requirements for the site based on your comments. Prior to beginning this work, we would like to confirm that the proposed methods for addressing each of your comments will sufficiently address the comments. Can you please comment on the adequacy of the proposed methods listed under each comment below? Additionally, can you please let us know which of the following testing would require DEEP to be present on-site, if any? We would like to get that scheduled as soon as possible, if needed.

- Proper calculation of horizontal hydraulic conductivity
  - **Proposed method:** *Performing Auger Hole Bailing or Slug Tests to estimate horizontal hydraulic conductivity*

I have no objection to the methods you are proposing for determining the range of hydraulic conductivity at the site, provided it is based on data collected on-site rather than on assumptions. As long as the recommended techniques and conditions are properly followed, both methods are acceptable for evaluating hydraulic conductivity at groundwater depth area.

- Information about the glacial till characteristics and how water moves through that layer
  - **Proposed method:** *If glacial till is encountered at depths of less than four feet, infiltration testing may be performed in the test pits. Otherwise, characteristics of the till will be determined from Auger Hole Bailing or Slug Tests.*

Similarly, I have no objections to the method proposed for characterizing glacial till, particularly in terms of understanding how wastewater may move through that layer if it is incorporated into the design. My concerns with the current design are specifically related to the assumptions made regarding aquifer thickness (50 feet) and hydraulic conductivity (300 ft/day), which appear inconsistent with the evidence of glacial till—a material known for its low permeability.

- Sufficient data to establish and determine the seasonal high groundwater elevation under all portions of the proposed dispersal area
  - **Proposed method:** *Estimates of seasonal high groundwater will be determined in test pits by visually identifying redoximorphic feature such as concentrations and depletions associated with fluctuations in groundwater.*

While seasonal high groundwater levels may be estimated based on these assumptions in stratified drift, it is important to note that redoximorphic features may not be as apparent or reliable in glacial till.

- Sufficient data on groundwater elevation, gradient and direction of flow (only 2 reading points on 2 dates were provided)
  - **Proposed method:** *Installing four additional monitoring wells within the proposed infiltration areas and providing readings every 2 weeks for 6 weeks total.*

While groundwater elevation, gradient, and flow direction can be reliably determined using a network of properly placed monitoring wells—including the two existing wells and the four proposed—I want to note that current conditions do not represent seasonal high groundwater. That said, useful information can still be gathered, and seasonal fluctuations can be reasonably inferred by referencing data from a nearby USGS monitoring well, provided that well is installed in a similar geologic setting and exhibits comparable groundwater fluctuation.

- Proper plotting of groundwater contours
  - **Proposed method:** *Create a plot of groundwater contours based on the additional testing proposed above.*

That is required.

- Saturated thickness of the aquifer under the site

- **Proposed method:** *Review the Surficial Aquifer Potential Map of Connecticut and provide saturated thickness of the aquifer based on the groundwater contours.*

*I'm not entirely clear on the objective, but I'm open to seeing how it develops.*
