Or don't

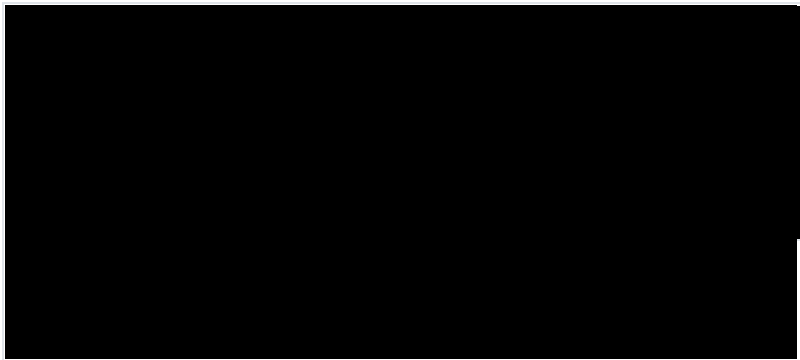
