Mayor's Budget Letter

- * Grand List for valuation yielded a net increase of 4.5% compared to last year's overall increase in the value of 1.3%
- * Grand lists for the most comparable towns to Ledyard in the area are two to three times higher than Ledyard leading to a heavy reliance on residential property taxes
- * Debt Service decreased \$448,820 compared to last year's increase of \$350,810
- * As of June 30, 2023, the town's pension plan was 84% funded compared to 80% as of June 30, 2022. The increase is attributable to sound management and favorable market conditions.






Proposed FY 25 Budgeted Revenues

American Rescue Plan Act

- * The Town receive a total of approximately \$4,327,000 from the American Rescue Plan Act
 - * Funds must be "obligated" by the end of calendar year 2024, "liquidated" by end of calendar year 2026
 - 24 projects completed
 - * 7 projects in progress
 - * 8 not started yet









Mil Rate Increase

- * Revenue from non-tax sources increased .04%
- * Healthcare costs continue to increase
- Inflation caused increases in utilities, materials, labor costs, and contracted services
- Projected mil rate increase 0.65 mils
