Hello Liz,

Attached is the third and final set of documents I would like submitted for the pre-application conference on Thursday, May 14.

I separated the Administrative section into a standalone PDF from the draft Design Guidelines document because I would like to focus discussion primarily on our proposed strategy for Section 3: Distinctive Characteristics. This was an element missing from the prior 2012 guidelines previously used for Ledyard and Gales Ferry, and I believe it is an important topic for the Commission's consideration.

The Architectural and the subsequent guideline sections are included at this time primarily as a courtesy so that the Commission can see the broader framework we have been attempting to develop for the guidelines. However, I do not expect there will be sufficient time to discuss those sections during this pre-application conference. More detailed review of those provisions will likely need to be reserved for a future pre-application discussion.
