V. MEMBER COMMENTS

The suggestion was made that a group could sponsor a luncheon and give the proceeds to charity.

Ms. Cobb asked what the hours were for the lunch and breakfast. Mr. Johnson responded breakfast is 8:30 - 10:30 and Wednesday lunch is 12:00 sharp and if there is a speaker, they speak at 12:30.

Ms. Cobb stated that last night was the budget meeting for the Town Council and our budget is very good and everyone should go out and vote for the budget. Mr. Johnson stated that the only thing changed was eliminated the full time van driver and added a part time driver and that money was moved to cover the cost of Schedules Plus which will save a tremendous amount of time scheduling the transportation.

Ms. Harding asked if the van could be used to take seniors to the celebration of life for Skip Quilter. Mr. Johnson responded that he does not want to set that precedent and that the service is on a Saturday during no-work hours.
