Good Morning Brian,

Thanks for reaching out. I offer the following, not as the one who has the ultimate authority to make the decision in this, but to delineate context relative to this particular bid and its result, as we had discussed in some measure in our phone conversation this past Tuesday.

In the 30+ years I have been in charge of securing and overseeing the Town's waste management services, we have bid for them eight times now (including this bid). In each previous case, as directed by the Town's Purchasing Ordinance, we went with the lowest responsible bid. This has involved a change of contractor on 3 previous occasions (not including cases of change of ownership while maintaining existing services). And even abiding carefully by the Purchasing Ordinance did not shield the Town from frivolous lawsuits on two occasions, that were ultimately thrown out. This speaks to how careful we are in following our contracting rules, and with respect to our municipal and curbside collection services have further tightened our bid specifications and process. Also, in every case where an bid resulted in change in contractor, transitional considerations did not override our decision. The Town actually absorbed the biggest transitional impact, not through change of contractor, but because of conversion from manual to automated collection. Now under automated collection service logistics, this will involve a more complicated transition, as you suggest, and we could avoid this if we continue our service through Casella/Willimantic, a company through whom we have enjoyed many years of great service and relationship, but this would involve considerations that would amount to a bypassing of the clear bid results, which is tacitly acknowledged by your offer.

I have copied in the Mayor, Finance Director, and Administrative Assistant to the Town Council (who will forward this to the entire Town Council) so that they may have and consider your offer directly. There is a scheduled Finance Committee meeting on Wednesday, March 19<sup>th</sup>, at which this matter is scheduled to be taken up. Regards,
