Episcopal Churchyard (#16) – 51 Spicer Hill Road, Ledyard : Overall maintenance for brush removal and clearing

Stoddard-Hurlbutt (#42) – 29 Kings Highway, Gales Ferry, Connecticut : overall maintenance to include tree pruning, brush clearing

Robert – Stoddard (#43) – 1841 CT-12, Gales Ferry, Connecticut : repair of several broken and fallen headstones and minimal brush clearing
