VII. COMMITTEE REPORTS

1. Sawmill Committee - Mr. Barnes

It has been a good experience with the alarm system, it has been activated for the last few months. Possibility of an issue with the motion sensors, but to date it has been fine with no false alarms.

Still waiting for the assessment on the Sawmill, it was supposed to be completed by the end of last week. Should have the assessment by Wednesday or Thursday of this week. Once the assessment is reviewed the repair list will be prioritized

2. Nathan Lester House - Ms. Dyson/Mr. Kelley

There has been some hiccups with the alarm system but overall things are going well. The smoke detector in the kitchen was swapped out for a heat sensor.

4th of July planning to start next month, Chairman Godino suggested reaching out to Mr. Moore to see if he would be interested in participating.

Mr. Lamb asked about the Ledyard Oak. The new oak tree was planted by Springs and Twigs, no dedication has been made. Not sure that it can be claimed as an off shoot of the Charter Oak, however the tree by the House is an off shoot of the Charter Oak. Further discussion to follow.

Mr. Lamb also asked about the website for the farm in Western Connecticut. The group will review/discuss and reach out to Mrs. Ericson as questions arise.

3. Research/Preservation - Mr. Lamb

Part of Preservation is to work with the Allyn Farm to preserve "very old varieties", from local apple farm. Bill S, Victoria and Ty are preparing to graft in these old apple trees into root stock. Planning to commence in April 2023.

Spicer Site - Need to reach out to Juliet Hodge, Gary Paul or Naomi Rodriquez to broach subject of land use for this site, which comes under the Town Council. Will attend the March meeting of the Tri-Town Trail. Ms. Ericson made mention of the Mystic Noank Library, they would have interest in having a tour of the Spicer site in relation to the mansion and the library being built by the Spicer's

Historic District signs - January 29th, Ms. Kelly, Ms. Ericson and Mr. Lamb conducted a tour of some of the Lamb's farm with included visiting the gold and sulfur mine of the late 1800's with GOSA. Approximately 8 GOSA members attended. Toured the proposal site for the Lambtown Historic and Garden site (pollinator).

Sign maker update - Preliminary sign concept (Lamb Homestead in the district 1714, 1st Baptist Church in Connecticut 1705, Lambtown School House, Farm scene, and others) and started discussions of cost.

Ms. Ericson and Mr. Lamb reached out to the Ledyard Garden Club (Ms. Levandoski), will have follow up conversations with her in near future.

Will attend the Ledyard Beautification Committee and Conservation Commission meetings to discuss.

Need to draft up an official proposal to GOSA, Ms. Ericson will edit.

Will attend some additional meetings (Town Council, Zoning, Land Use).

Virtual Path - Ms. Ericson and Mr. Lamb are still researching active grants, should have an estimated cost by the next meeting.

Completed the Art commission of the "Icehouse" painting (April Fleming).

4. Center School - Mr. Geer

An estimate was received from Mr. Kelley to repair the Schoolhouse exterior trim.

Repairs (replace with red cedar) to the South side, West side \$1,340 (includes painting).
